MEETING DESCRIPTION

The purpose of this public hearing, Docket # 2022-R-A-0006, is to address the Delaware second Particulate Matter Limited Maintenance Plan under the 2006 24-hour Fine Particulate Matter (PM2.5) National Ambient Air Quality Standard (NAAQS).

In December of 2009, the EPA designated the Philadelphia-Wilmington Area as nonattainment for the 2006 24-hour (PM2.5) NAAQS. In September 2014, the EPA redesignated the area as attainment. Redesignated areas are required to submit two ten-year maintenance plans to
